LAKE POWELL PIPELINE IMPACT ON DIXIE SPRINGS

Some of the residents of Dixie Springs have been getting information on the Lake Powell Pipeline Project. One resident let me have a copy of the two CDs she was mailed. I have looked through the CDs to see the impact the pipeline will have on Dixie Springs. Here is what I have been able to figure out.

There is a picture on page 3 that shows the path the pipeline will take. The picture on page 4 shows the path for the transmission lines. If you zoom in on the picture, you will see that there are new transmission lines that will hook up to the existing lines on the east side of Dixie Springs. The picture is not clear enough or detailed enough for me to see exactly where the new lines will go in relation to the streets in Dixie Springs. The appear to be along the existing lines.

Here are quotes from the documents on the CDs:

The proposed new Sand Hollow to Dixie Springs Transmission Line would consist of a new 69 kV transmission line, running from the Sand Hollow Hydro substation around the east side of Sand Hollow Reservoir and north to the existing Dixie Springs Substation. This new 69 kV transmission line would be about 3.4 miles long in Washington County, Utah.

The Hurricane Cliffs Afterbay to Sand Hollow transmission line and Sand Hollow to Dixie Springs transmission line construction would have significant, direct effects on recreation resources within Sand Hollow State Park. The construction would temporarily restrict dispersed recreation activities along the transmission line ROWs, and would temporarily close the Sand Hollow Road.


Significant, temporary, indirect effects including visual changes, air pollutants, noise, and additional LPP Project construction traffic


would occur on recreational resources and users within Sand Hollow State Park. Noise generated during transmission line construction activities would attenuate to background levels within 1,600 feet of the transmission line ROWs. Air pollutants would mostly disperse to below NAAQS concentrations within the ROW corridor; prevailing winds from the southwest would disperse air pollutants away from Sand Hollow State Park primary use areas. Additional LPP Project construction traffic would occur along the Sand Hollow Road and recreational users in vehicles would experience delays during transmission line construction.

The Sand Hollow to Dixie Springs
Transmission Line ROW, a portion of which
runs along the north shore of Sand Hollow
Reservoir, would be permanently closed to
recreation if required by the applicable
management plan. This potential permanent
closure would be a significant, permanent,
direct effect on recreation. Park users would
also experience significant, indirect effects, as
they view the transmission lines.

For me, there is a lot more information I would like to have. I would like to see a detailed map of these lines shown on a map that has the streets of Dixie Springs. I would like to know what the transmission line would do to the "view" for the people of Dixie Springs.

HOME CHANGES THAT REQUIRE DIXIE SPRINGS ACC APPROVAL

Many changes that you make to your home after it is built must be approved by the ACC. For example, you need ACC approval if you add an addition, a shed, restucco the house, add solar, add a shelter, add a wall, etc.

You need to provide documentation and a \$25 payment. A description of what you need to do is on this page:

If you do not get ACC approval, you may be subject to a fine process or may be required to make changes.

PARKING VEHICLES, TRAILERS, RVS, ETC IN THE STREET

Please remember that you cannot park a vehicle in the street for more than 48 hours.

Hurricane Ordinance, Title 6, Chapter 1, Section 6.1.3, Parking Regulations, D7

If you have a problem with vehicles or trailers parked more than 48 hours on the street, call the Hurricane police department at (435) 635-9663. Give them the street and a description of the vehicle or trailer.
